In most cases, we also sign a mutual non-disclosure agreement to safeguard and protect each other proprietary data.

### Website and statistics

We use WordPress to run our website, and we use Google Analytics\* to track our web traffic. This website uses cookies, from Google Analytics. Google Analytics is Google's analytics tool that helps website and app owners to understand how their visitors engage with their properties. It may use a set of cookies to collect information and report website usage statistics without personally identifying individual visitors to Google. The main cookie used by Google Analytics is the '\_\_ga' cookie.

We do not use non-functional or third party cookies on our website, which would require you to opt-in. We do not share information about your use of our site with social media, advertising and analytics partners who may combine it with other information that you've provided to them or that they've collected from your use of their services.
